#### **Data Protection Clause**

In accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC hereinafter referred to as the 'General Data Protection Regulation' we inform that:

## [Administrator, Inspector of Personal Data Protection, Contact Details]

- 3. The Controller has appointed an inspector of personal data protection, who may be contacted in terms of all matters regarding your personal data protection. ## [The Aim and the Basis of Personal Data Processing]

- 4. Personal data, that you have disclosed to us on the basis of your voluntary consent, will be processed by RADWAG:
  - (a) to send you a Newsletter to the email address provided by you, on the basis of Art. 6, par. 1 a) of the General Data Protection Regulation, i.e. on the basis of your voluntary consent to sending the Newsletter;
  - (b) for marketing purposes regarding products and services of the Controller, on the basis of Art. 6, par. 1 a) of the General Data Protection Regulation, i.e. on the basis of your voluntary consent to the processing of your personal data for marketing purposes regarding products and services of the Controller:
  - (c) to determine, seek or defeat possible claims between you and the Controller, on the basis of Art. 6, par.1 f) of the General Data Protection Regulation, i.e. on the basis of legally justified interest (the possibility to seek claims) of the Controller;
- 5. Providing personal data is voluntary. However, providing personal data such as name, surname and e-mail address is necessary to subscribe the Newsletter.
- 6. There will no further decisions nor profiling be taken towards you in an automated way.

# [Categories of the Personal Data Recipients]

- 7. Your personal data may be disclosed to the following entities: employees and associates of the Controller, IT service providers, hosting providers, entities providing consultancy and legal services.
- 8. Your personal data can be disclosed to entities and bodies authorized to process such data on the basis of legal provisions.
- 9. The Controller does not plan to transfer your personal data to a third country, i.e. a country which does not belong to the European Economic Area or international organisation.

### [Retention Period for the Personal Data]

- 10. Your personal data will be processed for the period necessary to fulfil the purposes for which it is processed (refer to section 4) or until the objection (if the basis of the processing is legitimate interest of the Controller) or until the consent is withdrawn (if the basis of the processing is the consent), depending on which of the events occurs earlier.
- 11. The Controller will store your personal data until the period of limitation has expired for possible claims.

### [Rights]

- 12. You have the right to access your personal data and to modify, delete or limit the processing of it.
- 13. You have the right to transfer your personal data, i.e. to obtain your personal data from the Controller who received it from you, using structured and commonly used machine readable format. You have the right to request from the Controller to send the data to other controller.
- 14. To the extent when your consent is the basis of the processing of your personal data, you have the right to withdrawn the consent. The consent withdrawal does not affect the legality of processing carried out on the basis of the consent prior to its withdrawal.
- 15. To the extent when the legally justified interest of the Controller is the basis of the processing of your personal data, you have the right to object to the processing of your personal data.
- 16. In order to exercise your rights you have to contact the Controller or the inspector of personal data protection using the abovementioned contact details (refer to section 2 and 3).
- 17. You have the right to submit a complaint to the Regulatory Body (the President of the Personal Data Protection Office) in case of considering that processing of personal data violates the provisions of personal data protection.
